It is therefore not possible for this to identify and name who is the 2<sup>nd</sup> applicant since the name was not indicated in application dated 5<sup>th</sup> July 2012. I think the practical direction to give is that proposed by Mr. Kaka. Consequently, I hereby direct learned counsels appearing in this matter to each provide the names and status of their clients as at the date of this order. This matter to be mentioned on 30/11/2021 to ascertain whether the advocates have provided the information and to give further orders and directions.
