JUDGMENT

The Applicants, T D and A I D are German citizens. They were married on 15th July 1997. The 1st and 2nd Applicants are teachers employed by the *[particulars withheld]*, in the State of Schleswig-Holstein. The Applicants have so far not been blessed with any children due to medical reasons. The Applicants wish to adopt a child. The Applicants approached the relevant authorities in Germany with a view to securing the requisite approvals to enable them adopt a child, specifically a foreign child. The Applicants were investigated by HELP a Child e.V. Children Find Parents – Germany, a foreign adoption society duly approved by the Federal Central Authority for Intercountry adoptions under the Federal Office of Justice in Germany. The said authorities approved the Applicants’ application to adopt a child from Kenya on 16th October 2011. The National Adoption Committee of Kenya duly approved the application by the Applicants to adopt a child in Kenya. The approval certificate to that effect was issued on 23rd May 2013.

Baby A L *alias* A W, the child, the subject of these adoption proceedings was found abandoned in Dagoretti on 25th March 2012 in Nairobi. A report was made to Dagoretti Police Post. Thereafter, the child was released to the custody of Nest Children’s Home. She was placed under the care and protection of the said children’s home by the Nairobi Children’s Court by an order issued on 16th July 2012 pending these adoption proceedings. The child was placed under the custody of the Applicants for compulsory foster care on 5th July 2013 for compulsory foster care. Since then, the child has been in the care and custody of the Applicants. According to the police, their effort to trace the biological parents of the child has been in vain. No one has come forward to claim the child. A report to that effect has been filed in court. No one has come forward to claim the child. This court therefore dispenses with the consent of the biological parents to the proposed adoption by the Applicants. KKPI, an Adoption Society issued a certificate declaring the child free for adoption. The certificate is dated 27th March 2013.

The court read the reports prepared by KKPI, the local adoption society, the Department of Family and Welfare Children Services Fostering and Adoption Placement – Kiel, Capital of the Federal State of Schleswig-Holstein and HELP a Child e.V. Children Find Parents – Germany, the Director of Children’s Services and by S N, the guardian ad litem. All the above reports are favourable and recommend the Applicants’ application to adopt the child. This is an international adoption. There are certain conditions that the Applicants must fulfill before this court can allow them to adopt the child. The first condition is that the Applicants must be approved by the relevant adoption authorities in their country of origin. In the present case, the Applicants have been assessed and approved by the relevant authorities in their country of origin, Germany. This court had the benefit of reading the report prepared by the foreign adoption society. This court is satisfied that the Applicants have been approved by the relevant authorities in Germany to adopt a foreign child, and specifically a Kenyan child. The second condition is that the

Applicants must be approved by the National Adoption Committee in Kenya to adopt a child in Kenya. The Applicants have been assessed by the said National Adoption Committee. A certificate has been issued by the said committee approving the Applicants' application to adopt a child in Kenya. The third condition is that the Applicants must satisfy the court that they have fulfilled the legal requirements regarding the adoption, including having custody of the child for a sufficient period to enable bonding to take place. This period must not be less than three (3) months. It was clear to the court that the Applicants have fulfilled all the legal requirements in respect to international adoption. The Applicants have had the custody of the child since 5th July 2013. In the period that the child has been in their custody, the child has bonded with them. This was evident from the reports prepared by the Director of Children's Services, the guardian ad litem and the local adoption society. The Applicants have established that they have the financial and emotional capability to take care of the child.

Having evaluated all the reports on record, and the Applicants' application seeking to be granted permission to adopt the child, it was clear to this court that it would be in the best interest of the child for the application for adoption to be allowed. The Applicants have given an undertaking that they shall allow access to the approved adoption society in their country of origin to undertake post-adoption supervision for a period of three (3) years from the time of the issuance of this adoption order. The Applicants have executed an undertaking that if this court grants the adoption order, they will permanently assume all the parental rights and duties of the biological parents in respect of the adopted child; they shall treat the adopted child as if she was born to them in their marriage; they have been made aware that once the adoption order is issued, it shall be final and binding during the lifetime of the child that they shall adopt; that the child shall have the right to inherit their property; that an adoption order cannot be recanted, and further, that they shall not give up the child owing to any subsequent unforeseen behaviours or other changes in the child; that the adoption society in Germany (foreign adoption society) shall provide annual follow up reports on the progress of the child to the adoption society in Kenya (local adoption society) for a period of three (3) years from the date of the arrival of the child in Germany; that the Applicants undertake to allow the representatives of the foreign adoption society in Germany free access to the child at any reasonable time. The Applicants further give an undertaking that they shall accord their citizenship to the child.

In the premises therefore, this court finds that the Applicants have met the criteria set for international adoptions. The Applicants, T D and A I D are hereby authorized to adopt baby A L *alias* A W. The child shall henceforth be known as A W M D. Her date of birth shall be 24th March 2012. Her place of birth shall be Nairobi, Kenya. A B and F B, friends of the Applicants are hereby appointed to be the legal guardians of the child should misfortune befall the Applicants. The Registrar General is hereby directed to enter this order in the Adoption Register. The guardian ad litem is hereby discharged. It is so ordered.
