**RULING**

1. The Applicant filed a Chamber Summons Application dated 9<sup>th</sup> September 2025 which sought the following orders: -
  - i. Spent.
  - ii. That at the inter parties and/or further hearing of this Application, the Garnishee nisi be made absolute and the monies attached be released to the Decree Holder/Advocate/Applicant, O.M Otieno & Company Advocates to satisfy the decretal sum outstanding at the time of determination of these proceedings.
  - iii. That costs of this Application be provided for.
2. The Application was brought under the provisions of Order 23 Rule 1(1) of the Civil Procedure Rules and sections 1A, 1B and 3A of the *Civil Procedure Act* and it was based on the grounds on the face of the Application and further by the Supporting Affidavit sworn by Ouma Maurice Otieno Advocate on 9<sup>th</sup> September 2025.



3. In the lead file being Misc. Civil Application Number E010 of 2022, Ouma Maurice Otieno t/a O.M Otieno & Co. Advocates vs Africa Merchant Assurance Co. Ltd & another, this court directed that the order arising from the referenced file shall apply to this file.
4. In its Replying Affidavit dated 15<sup>th</sup> October 2025 sworn by Cerere Kihoro, the Garnishee's legal counsel, the Garnishee stated that the Respondent operated Till Numbers 545400 and 4106404. The Garnishee further stated that till number 4106404 had sufficient funds to satisfy the outstanding decretal sum. It was the Garnishee's contention that they had set aside the sum of Kshs 164,732/= and were willing to remit the sum to the Applicant.
5. Flowing from the above, I make the following orders: -
  - i. An order for Garnishee Absolute is issued against Safaricom PLC that all monies belonging to the Judgement Debtor (Africa Merchant Assurance Company Limited) and held by the Garnishee in Till Account Number 4106404 be attached to recover Kshs 164,732/= owed to the Applicant by the Respondent.
  - ii. Each party shall bear their own costs in this Application.
