7. Mention on 30/04/2025 for further directions.
8. All the parties known to be collecting rent from the properties mentioned in the Directions issued on 23<sup>rd</sup> April, 2024 are given 14 days to comply with the said orders. The evidence of the deposit of the rent in court must be availed within the 14 days as the matter is mentioned on 11/3/2025.
